

# Website Terms of Use

## **Acceptance of the Terms of Use**

These terms of use are entered into by and between You and En Ka Society, Inc. (“**Organization**,” “**we**,” or “**us**”). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, “**Terms of Use**”), govern your access to and use of the website enkasociety.org, including any content, functionality, and services offered on or through enkasociety.org, (www.enkasociety.org, the “**Website**”), whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Website. **By using the Website or by clicking to accept or agree to the Terms of Use when this option is made available to you, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy, found at enkasociety.org, incorporated herein by reference.** If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Website.

By using this Website you represent that you are at least 13 years old. If you are not at least 13 years old, you may only use the Website if your parent or guardian consents and assumes full responsibility for your use of the Website.
